Curriculum vitae

Education

Antonio Angelucci (italian citizenship) is graduated in Law from the University of Pavia (2001) and was a student at the Borromeo College. After graduation he started to work in a law firm in Milan and became barrister (2004).

Always attentive to issues of philosophy of religions, he started a Ph.D. in Philosophy of Law (*curriculum* Law and Religion) in 2010 and got his Ph.D. degree in 2013.

The growing phenomena of hatred and discrimination against religions and minorities prompted him to deepen his studies of comparative religions and comparative religious laws (MA in Canon Law and Comparative Ecclesiastical Law, *Summa cum Laude*, 2017, *curriculum* in Comparative Religious Law with a theological, philosophical and juridical *curriculum studiorum*) and led him to become a researcher at the International Institute of Canon Law and Comparative Law of Religions of the Faculty of Theology of Lugano (Switzerland).

Teaching

He currently teaches four courses in the Faculty of Theology of Lugano: Islamic Religious Law, Islamic Family Law, Buddhist Law and Hindu Law. Philosophical and theological issues are discussed during the lessons together with legal themes.

He was a post-doc research fellow, first at the University of Insubria with two teaching assignments in Religious rights and community and family mediation and Comparative law of religions (2015-2016) and then at the University of Milan-Bicocca at the School of Law, an Italian Department of Excellence (2016-2019).

He has been teaching at the University of Piemonte Orientale of Novara European Ecclesiastical Law since 2015 (with a focus on intercultural law) and has been dealing with security in the MENA area, inclusive citizenship and intercultural and interreligious dialogue, paying particular attention, first of all, to anti-Semitism and to Islamophobia; he has also given courses since 2019 in Canon Law with a particular reference to comparative religious law.

In response to the COVID-19 outbreak he has acquired online teaching experience both in Italy and in Switzerland, by giving lectures and seminars with the most common video communication platforms (Panopto, Meet, Zoom).
