(in preparation) The Egyptian Crime Formula: Citizens' Quest for Justice in Egyptian Television Drama. For: BRILL (Leiden Studies in Islam and Society).

This manuscript is the first attempt to capture the potentials of considering (Egyptian) television drama as a formant of law in the region, and it does so by focussing on the portrayal of crime investigations. Its core chapters engage with various kinds of portrayal while discussing key elements of literary genre, social class, actorial intertextuality, gender, and political control. The first chapter (Framing the Imaginaire: Lam, Television Drama, and Irreality) looks into the potency of the vraisemblance in the context of a largely absent unmediated experience through the lens of crime investigations in comedies. The second chapter (Bulletproof Foreign: Formats, Consumption, and Brutality) analyses the (largely marginal and unsuccessful) adaptations of foreign formats in Egyptian crime drama, and their strong class representations. The third chapter (Sidelining Distrust: Adaptation, Marginality, and Inconsequence) frames the success of an adaptation of a foreign production in its stripping of the key format element of the crime investigation. The fourth chapter (Struggling Heroes: Justice, Gender, and Mental Health) analyses the core of the 'Egyptian' crime drama genre through the works of two actors embodying in their series (slightly) different understandings of justice. The fifth and final chapter (Contriving Trust: Hegemony, Position, and Surveillance) looks at the transformations of the production and distribution industries and the active engagement of the state in trying to establish a new hegemonic model of police or army presence in crime drama investigations.

(in preparation) Conflicting Semiotics of Law and Governance in early Nineteenth Century Egypt. For: BRILL (Studies in Islamic Law & Society series)

Within my broader interest in the appropriation and displacement of figh terminology in modern and contemporary legal Arabic, this manuscript zooms in on one of the key moments in which a new semiotics of law and governance started emerging in Egypt: the 1820s through the 1840s. Its core chapters consider momentous instances in this transformation. The first core chapter engages with an early manuscript translation of Machiavelli's *The Prince* (1822), the second and third focus on early issues of the Official Gazette (chapter 2 on the semiotics for foreign constitutional systems, and chapter 3 on the domestic policy of law enforcement) (1829-1930), the fourth analyses Tahtâwî's rendition of the 1814 French Constitutional Charter in *Takhlîs al-Ibrîz* (1832), and the fifth considers the issues of the Official Gazette that were published after Tahtâwî's appointment and before the stricter controls from the Sublime Porte that followed the 'Oriental Crisis' (1842).

The manuscript proposal has been accepted in the prestigious series directed by Ruud Peters, Kevin Reinhart, and Nadjma Yassari: *Studies in Islamic Law & Society* at BRILL.

Citizenship in the Arab World is a book that has become the reference work on citizenship legislation in the region. Not only does it provide a full comparative reading of citizenship regulations, but it also situates matters of citizenship within the historical and ideological developments in the region. It considers both 'passport' citizenship (jinsiyya) and constitutional citizenship (mumâtana) in their various articulations and entanglements. The book has a preface by Rainer Bauböck and a foreword by Gerard-René de Groot. It was selected to be included in the EU Network of Excellence IMISCOE's research series and published by Amsterdam University Press. It is now in open access format.

Dimensioni dell'appartenenza e cittadinanza nel mondo arabo (Naples: Jovene, 2007)

Largely based on my doctoral dissertation, this thick and heavily footnoted book engaging with matters of belonging and citizenship in jurisdictions with Arabic as their official language has been now in use as a teaching text for a number of Islamic and Middle Eastern Law classes in Italy for over ten years. The book was selected to be included

in the Law School series (the predecessor of university presses in Italy), and thus published by a commercial publisher. The publication was funded by a highly competitive state grant awarded by the Italian National Research Centre (CNR).

Legislation as a way to regulate personal status matters has — over the period considered — come to embody the chief mode of (legal) reform of personal status. While recognising its tremendous impetus, this paper interrogates the very form of collective decision-making that legislation signifies, its operationalisation in adjudication, and its interrelation with popular culture. The three contributors identify some of the areas where these dynamics have surfaced in their experiences as both academics and practitioners and consider the Egyptian legal system, which is meant to function as a case study rather than a normative model. To appreciate the functioning of collective decision-making on matters of personal status, Nadia Sonneveld focuses on the different approach of the state towards the regulation of personal status for its Muslim and non-Muslim citizens. The 'best interests of the child' is the lens through which Nathalie Bernard-Maugiron illustrates the multiple entanglements of legislation and its eventual actualisation in Egyptian courts. Enas Lotfy discusses the classical examples of Egyptian cinema that are popularly associated with changes in legislation and underlines how the big screen in Egypt has often been the place where some of the most contentious and divisive matters of personal status have been discussed before (or away from) legislative intervention.

2015 Comment parle-t-on de « droit » en Égypte ? (journal issue). Etudes Arabes. 112:1-146.

This collection of parallel texts shows the dramatic transformations of the vocabulary of law from the emergence of the modern state to today's Egypt. I selected six texts from the early 1820s to the early 2010s, and reviewed the translations from Arabic into English, French and Italian by colleagues and former students at PISAI. My introduction identifies the major trajectories and oscillations in the appropriation and dislocation of fiqh terminology by the modern state and its law. This work is at the origin of the desire to further comprehend and illuminate the transformations during the first quarter of the 19th century (the manuscript currently in preparation for 2022), and the grant application generously awarded by AKU's URC to compare the transformations of the vocabulary of law a century or more later during the establishment of law schools in Cairo and Beirut.
